## NINA SIMONE RIDER FOR HOTELS, NIGHT CLUBS, AND THEATRES:

- 1. It is hereby understood and agreed that operator shall provide a boom mike for Artist's use during performance.
- 2. Operator also agrees to provide Artist with a baby grand piano tuned to the standard 440 pitch and said piano shall be kept in tune for the duration of the engagement.
- 3. Operator agrees to provide Artist with a public address system of first class quality along with two additional microphones other than the above mentioned boom mike.
- 4. Operator shall provide a technical rehearsal period, with adequate technical lighting and sound personnel, at a time to be designated on opening day of engagement.
- 5. Operator agrees to provide Artist with a four-legged stool approximately three feet high.
- 6. Operator agrees to provide dressing rooms for Artist and her trio and said dressing rooms shall be equipped with proper lighting and water facilities.
- 7. Operator agrees to furnish Artist's agency with a list of all other artists and/or acts which will appear on bill with Artist. Said list must be sent to agency at least ten days prior to opening of engagement.
- 8. It is understood and agreed that Artist will not perform before segregated audiences of any nature.
- 9. Artist is to receive 100% sole star billing.
